
During 1996 changes were made to the AAA to accommodate various political changes on the African continent. The rules now require a contact with each of the six ZS call areas and 25 African countries outside South Africa.

ZS3 callsigns were issued in South West Africa during its administration by South Africa. On the 21st of March 1990, South West Africa became the new independent country Namibia (V5); thus your contact with V51HL counts for Namibia (the old South West Africa) and not for a ZS3 which is now issued in the North Western part of the Republic of South Africa.

Except for a contact with a ZS3 your application meets the criteria for the AAA but has been put on hold till you can provide me with the details of a contact with a ZS3 station - no card is required as I will confirm that contact with that station to expedite your award.

ZS3 is surely the most difficult to contact as there are very few amateurs and few of those work DX. The good news is that Jaap van der Linde ZS3JP is active and can be contacted by e-mail at [vdicompu@telkomsa.net](mailto:vdicompu@telkomsa.net) so do make a sched with him. I repeat: no card is required as I will confirm that contact with ZS3JP to expedite your award as soon as you let me know that you have made a successful contact with Jaap.
